

City Council Minutes
April 6, 2016

The City Council meeting was called to order by Mayor Hamm followed by a request for roll call. Present were Alderpersons Jenkins, Bridick, Vrabc, Hampsey, Foley, Riskovsky, Haynes and Gardner. Absent: None.

All present recited the Pledge of Allegiance.

It was moved by Alderman Bridick, seconded by Alderman Gardner, to approve the minutes of the regular meeting held on March 22, 2016. Voice vote as follows: eight (8) ayes; no nays. Absent: None.

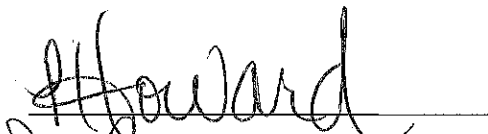

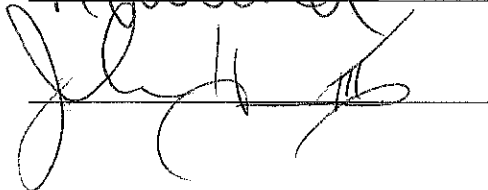
