

City Council Minutes
May 3, 2016
Minutes

The City Council meeting was called to order by Mayor Hamm followed by a request for roll call. Present were Alderpersons Jenkins, Bridick, Vrabec, Foley, Riskovsky, Haynes and Gardner. Absent: Hampsey.

All present recited the Pledge of Allegiance.

It was moved by Alderman Vrabec, seconded by Alderman Bridick, to approve the minutes of the regular meeting held on April 19, 2016. Voice vote as follows: seven (7) ayes; no nays. Absent: One.

It was moved by Alderman Vrabec, seconded by Alderman Bridick, to approve the presentation of Claims. Voice vote as follows: seven (7) ayes; no nays. Absent: One.

It was moved by Alderman Vrabec, seconded by Alderman Bridick, to approve Claims as presented in the amount of \$212,899.96. Roll call vote as follows: Ayes: Jenkins, Bridick, Foley, Riskovsky, Vrabec, Gardner and Haynes. Nays: None. Absent: One. Motion carried.

It was moved by Alderman Vrabec, seconded by Alderman Bridick, to approve the Comptroller's Report as presented. Voice vote as follows: seven (7) ayes; no nays. Absent: One.

It was moved by Alderman Haynes, seconded by Alderman Bridick, to approve the appointment of Dawn Davis to Police Pension Board. Roll call vote as follows: Ayes: Jenkins, Bridick, Foley, Riskovsky, Vrabec, Gardner and Haynes. Nays: None. Absent: One. Motion carried.

Mr. Owens addressed the Council, answering questions and providing an update on River's Edge Project.

Public Works Director Treadway provided accolades to Mike Foley and Mayor Hamm for their assistance when needed in the Public Works Department.

It was moved by Alderman Vrabec, seconded by Alderman Haynes, to accept the reports of the Department Officers. Voice vote as follows: seven (7) ayes; no nays. Absent: One. Motion carried.

It was moved by Alderman Vrabec, seconded by Alderman Bridick, to open and approve bids received for 1836 2nd Street and 300 Central. Voice vote as follows: seven (7) ayes; no nays. Absent: One. Motion carried. No bids were received.

It was moved by Alderman Bridick seconded by Alderman Vrabec, to allow Mayor Hamm to enter into an agreement with St. Louis Region SCCA to hold four (4) Rally Cross events in May, June and July on the grass field at Route 203 and Big Bend Road. Roll call vote as follows: Ayes: Jenkins, Bridick, Foley, Riskovsky, Vrabec, Gardner and Haynes. Nays: None. Absent: One. Motion carried.

It was moved by Alderman Haynes, seconded by Alderman Riskovsky, to approve request from Willie Tilmon to place property located in the 700 block of Jackson Street up for surplus property. Roll call vote as follows: Ayes: Jenkins, Bridick, Foley, Riskovsky, Vrabec, Gardner and Haynes. Nays: None. Absent: None. Motion carried.

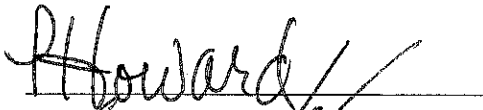

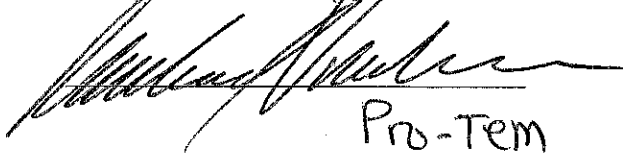
It was decided by the Council to table Agenda items 13 through 15 regarding the redevelopment agreements until the next meeting.
