Finance Committee Meeting November 13, 2018 Minutes

The Committee meeting as a whole was called to order by Mayor Hamm at 5:30 p.m. Present were Aldermen, Jenkins, Bridick, Vrabec, Hampsey, Riskovsky, Haynes and Gardner. Also present were Attorney Papa, Patricia Howard, Donna Hampsey, Jim Broadway, Robbie Robbins, and Wilbur Glasper.

The presentation of the City of Madison, Illinois Annual Financial Report for the Year ended April 30, 2018 was presented by Donohoo, McCalley and Associates. The Auditor provided an economic comparison of the City's financial activities for the year ending April 30, 2018. Some of the financial highlights included, city governmental funds took in more than \$7,780,987 revenue, which exceeded the expenditures of \$5624,262. Which means the City took in 39% more in revenue than it spent for the year.

Auditor felt that based on the information provided in the audit, the City of Madison is in a healthy position. However, they would provide information on whether or not the City would need to issue bond or raise taxes on December 10, 2018. This money will be used to help offset the funds needs for the police pension.

The Annual Financial Report for the year ending April 30, 2018 was distributed to the Council.
