January 4, 2021

The City Council meeting was called to order by Mayor John Hamm at 6:00 p.m., followed by a motion by Alderperson Hampsey, seconded by Alderperson Riskovsky for Sue Beatte to sit in as City Clerk in place of Pat Howard Voice vote as follows: eight (8) ayes; no nays.
