Report by Mayor:

The Mayor would like approval to purchase a new trash truck. Currently the arm truck we have now is a 2015 and is in the shop for damage at a cost of \$55,000.00 and has had over \$200,000.00 in additional repairs since the City has owned it. The other two trucks that are used for trash collection are a 2013 and 2006 Volvo. It is stated that using the arm truck keeps the Worker's Comp cases down instead of the guys walking and throwing the can. Alderperson Crochrell would like to get the arm truck we have fixed and just continue on as is. It was asked where the money would come from for the truck which is around \$458,000.00, the Mayor stated that it could be taken out of all of the TIF as this truck services those areas. It was also brought us by Scott Oney about maybe raising the trash bills to cover the cost. At this time the council does not wish to move forward with the purchase.
