Mayor reported on the street department that we have 3 to 4 guys cleaning up the alleys to help with the mosquito population.

Police Commissioner Donald Turner gave an update about the police sign ups. So far there have been 15 sign ups 8 female and 7 males. Signups continue through Midnight on August 29, 2022.
