Minutes
June 17, 2024

The City Council meeting was called to order by Mayor Pro Tem Crochrell at 6:00 p.m.

All present recited the Pledge of Allegiance.

Follow by request for roll call. Present were Alderperson Dixon, Crawford, Johnson Miller, Garrett and Morris Absent: Browley

It was moved by Alderperson Miller, seconded by Alderperson Morris, to approve the minutes of the regular Council meeting held on June 3, 2024. Voice vote as follows: Six (6) ayes; no nays Absent: Browley Motion Carried

It was moved by Alderperson Morris, seconded by Alderperson Dixon, to approve the presentation of the Comptroller's Report as submitted and that bills be allowed as drawn on the treasury and presented to the Council, unless there are any questions of the Summary of Expenses for the period of June 3, 2024 through June 17, 2024 in the amount of \$256,864.36. Report of Department Offices:

Public Works Director was asked about the lights on 7th Street Basketball court. He advise the lights are turned off by the Police at a certain time.

Chief of Police stated the Police Academy went real with about 20 participants. Nascar kept a lot of people really busy. They expect more next year.

Director of Public Works advise it was a big blow up this weekend on Madison Avenue between 2nd and 3rd Street. Barricades were placed. There was damage to the lid. They are tearing down houses. They hired 3 Youth Workers this summer, Carl Moore, Mr. D Williams and Tyrese Thompson.

City Engineer received bids for Phase 1, 3rd Street project, chain of rocks bridge expectation. ACT Grant application is July 1, 2024. They have bids to do patch work on Madison Avenue. Alderperson Morris asked if there can be a sign that say "OPEN BID" on the outside just in case a contractor pass by and maybe interested in placing a bid.
